General Information

As a food vendor, you must abide by all MDARD (Michigan Department of Agriculture & Rural Development) rules and regulations. For the health and safety of our customers, your items must either be prepared in a licensed commercial kitchen or fall under Cottage Food rules. If you are a licensed food vendor, you must submit a copy of your license. If you are a Cottage Food vendor, you must follow all rules and labeling standards or we will ask you to remove your items. (For more information regarding Michigan Cottage Food Rules and Regulations please visit: https://www.michigan.gov/mdard/0,4610,7-125-50772_45851-240577--,00.html) If you make and sell any pet food/treats, you must provide a copy of your Commercial Fee License.

Set up for the event will begin at 12:30 p.m. All vendors MUST arrive no later than 1 p.m. to allow the Downtown DeWitt Christmas Market to open promptly at 2 p.m. The Christmas Market hours are 2-5 p.m.

- I understand that this is an outdoor event.
- I understand that the Christmas Market may have to be cancelled or rescheduled due to extreme weather (e.g. high winds or dangerous weather threats) or updated COVID-19 restrictions at the time of the event.
- I understand that my applications will not be reviewed until I have submitted photos of my products, photos of my booth set-up (see above for more information), and any necessary licenses. I will submit everything by October 29, 2021.
- I understand that I will have to provide all electrical cords/surge protectors, carts/hand trucks, generator, and anything else necessary to successfully sell my product.
